### Samantha and Cindy – Trail Ownership:

• Sam had interaction via text with Mr. Ricky Roe Rains asking if he would kindly share with members of Spruce Creek Trail Assoc. and property owners within the Spruce Creek neighborhood and its visitors of South Fork Properties trail closures due to their road building, land clearing, land development etc. It was mentioned that Mr. Rains' personal Facebook page nor the business page, Big South Fork Land Sales is not visible to or known by many Spruce Creek residents and visitors and that the dissemination of safety information, as widely as possible, is this Boards concern. It was also noted to Mr. Rains that the Official Spruce Creek Trail Association is a public page and available to all to post information. During the text message exchange, Mr. Rains asked if SCTA would be performing trail maintenance on trails privately

owned by South Fork Properties. Mr. Rains was invited multiple times to attend a board meeting to review and discuss South Fork Properties development plans and its impact on trails and trail maintenance potential requirements. It was discussed and the Board decided to send Mr. Rains an email asking if the South Fork Properties agreement to supply the materials required for such maintenance, made in the past, remains intact, If so, which trails he wished SCTA to perform work on, and since many individuals volunteer for trail maintenance, that the trails owned by South Fork Properties would be open access to all.

- Laurie attended and updated the board on which trails are owned by SCTA, which ones have lease
  agreements and which trails within the Spruce Creek neighborhoods are on private property. A new
  updated trail map is forthcoming and will be available.
- Laurie also plans to meet with Fentress County Highway Dept. to discuss and review which roads are considered County roads and which remain privately owned. It was also discussed the possible areas for some trail re-routes.
