# Daniel and Terry - Trail Workdays:

- The June 25<sup>th</sup> trail maintenance day yielded 9 volunteers. Daniel Johnson led a "crew" over to Trail Head Lane where rock was trailered into the trail toward the Cumberland Valley Trailhead to repair a large mud/rutted area. Material was placed down before the rock to help prevent the material from further sinking and help drainage.
- Other volunteers took side by sides and did some trimming of overgrown branches on Wildcat Den Trail & along Spruce Creek Dr. trail
- During the month Glenn & Kathy Brown installed the new sign at the Troxel-Woods Trailhead

<u>Upcoming project:</u> Daniel offered to spread the load of rock noted below as "Morphis reroute" upon delivery.

## Laurie - Summary of latest trail Committee meeting

- Annual meeting with PARK cancelled at the last minute.
  - Ricky Raines attended the meeting.
  - Waiting for reschedule of meeting proposed Aug. 3<sup>rd</sup>
- R. Livingston/Reynolds Trails meeting:
  - It was determined that both the 700' x 20'-30' wide trail between Reynolds and Morphis, and the 600' x 10' trail behind the Reynolds lot 294 still belongs to R. Livingston. R. Livingston will deed both of these properties to SCTA if we take the initiative to have the necessary paperwork created.
  - Laurie requested and received unanimous approval for \$600 for surveys and another \$200 for legal expenses to create deeds.
- Morphis Reroute:
  - Lot 219-Morphis. Lot 220 was given to their son, Jay Spurlock, who is building a house and adding a driveway. Because of this, the "Sandy Rock" trail is blocked with a temporary barrier. The trail in front of the Morphis property can be re-routed to the county owned property (found markers). The route was verified and Morphis agreed (they may move their mailbox and planter). SCTA owns a 30' cut thru trail between Spurlock Lot 220 and trail to be deeded to SCTA. Laurie requested and received unanimous approval for \$300 for rock to be used for the erosion area in front of Morphis lot, and another \$120 for temporary "Trail this Way" signs. The property along Spruce Creek Drive will need to be mowed and have several permanent trail markers added.

#### Laurie – Visits the Court House and Tax Accessor:

 Laurie went to both the Court House and Tax Accessor to make the corrections to the boundaries on Reynolds lot and to update the necessary records to show that R. Livingston owns the 600' trail behind Reynolds lot and 700' trail between Reynolds and Morphis.
