#### **Pavilion News**

- Pavilion Usage and Clean-Up It's been reported that the pavilion hasn't been being kept up as it has been

# <u>Laurie – Summary of latest trail Committee meeting</u>

- Morphis Reroute:
  - 12 "Trail Directional Arrow" signs and 2 "Trail Closed" signs are completed and posted.
- R. Livingston/Reynolds Trails:
  - Tim Goade was provided an email with supporting documentation regarding the R. Livingston/Reynolds trails. We are on a 2-3 month waiting list.
- Davidson deed research/discuss with R. Livingston:
  - Wording requires clarification. The wording in deeds for lots 334, 335 and 226 for trail running along Spruce Creek Dr. (by horse head) "This conveyance is made subject to the provisions in the restrictive covenants and on the plats pertaining to horse trails, and the surviving partner of L&M Land company shall have the right to deal with the horse trails in the future without any further accounting to the grantees herin."
- Other: Assessor Maps and database corrections have not been updated yet:
  - Show correct boundaries for Reynolds lot.
  - Show R. Livingston owns 600' trail behind Reynolds and 700' trail between Reynolds and Morphis.
  - Kathy Brown offered to look into Tennessee Trail Advisory Committee to see if they are active and if we want to participate.

## **OLD BUSINESS:**

### • Samantha & Cindy Meeting Park Officials:

- Samantha & Cindy met with NPS Superintendent Niki Nicholas & Chief of Visitor & Resource Protection Tony Garner on August 1st. Ricky Rains was invited and had attended an originally scheduled meeting, but the Park had to cancel last minute. He was unable to attend this one. But he will be provided a summary. It was a very productive, informative & enlightening meeting. SCTA was assured by NPS that Cumberland Valley Trail Head was not in jeopardy of closure due to some trails leading toward the trailhead being on privately owned land. SCTA is working closely with NPS to maintain access via Proctor Ridge Trail Head. SCTA expressed its desire to maintain a close working relationship with the BSF/NPS to preserve the trails and our willingness to assist in any way we can. Proctor Ridge will be the SCTA/BSF "Adopt A Trail" project for 2023.
- Need new signs with proper placement to include but not limited to...:
  - No tying of horses to fence (4 from Crabtree?)
  - "You Are Here" will be updated after final trail map updates are completed.
  - Laurie recommended that the trail signs be redone.
