Marilyn Spoon (appointed 9/2023) and Terry Stedman (elected 6/2021) have agreed to run for an additional term. Regretfully, Robin Voss will not be available for a 2<sup>nd</sup> term. We will include a request for candidates in upcoming member communications.

## LAURIE: "DID YOU KNOW" COMMUNICATIONS

The board members discussed the possibility of presenting a series of "did you know" e-blasts/Facebook posts to inform members and others about the SCTA. Subject discussed could include: who built the pavilion, 20 years of trail expenditures, SCTA deeds, easements and agreements.

## LAURIE: RESULTS OF VOTE: CLASSES C & D (NON-SPRUCE CREEK OWNERS)

After the ballots were counted, we received 4 additional ballots with eligible post marks (March 16<sup>th</sup>). The final adjusted numbers:

86 ballots mailed

56 Voted to Retain the right to vote for board of directors = 91%

6 Voted to relinquish the right to vote for board of directors=9%

62 ballots returned - 72%

#### **JAY LIGHT: SIGNS PROJECT**

Jay presented a wooden frame to encase the 24" X 18" SCTA Trail Use signs. This will prevent them from being damaged/removed. The Board approved the design and placement of 6 of them throughout the SCTA trail system. Jay and Karen will check on the cost of 6 more signs from Crab Tree Sign Co.

## **LAURIE: CHARTER CHANGES**

The Board thoroughly reviewed the current charter, associated TN NFP laws concerning Charter Amendments (48-60-105, 48-60-301), the Charter Change form, and suggested changes. After considerable discussion, the board agreed to submit 4 Charter changes. Laurie will prepare the form and documents for final approval. A special board meeting will be held on April 23, 2024 to focus on the issue of Landowner eligibility to vote on land related matters, as well as a number of other by-law change recommendations submitted by the by-laws committee.
