Our newly formed TRAIL TEAM has been tasked with addressing some larger maintenance/drainage issues, BSF coordination/projects, revitalizing maps/signage, and acquiring alternate trail routes where our access to the BSF may be in jeopardy.

The SCTA is aware of the recently placed signs, by a private land owner, indicating "Private Property & Trails" prohibiting campers, day riders, and enforced by video surveillance. These restrictions DO NOT apply to the majority of the trails in Spruce Creek, which are owned/managed by your SCTA. Regardless of the entry point (from the PARK, Spruce Creek property, or the surrounding areas), ALL riders and hikers are welcome on the SCTA TRAILS.

As we welcome many new residents to the SCTA community, our TRAILS and our Park access become an ever more important contributor to our lifestyle and property values. Committee members may be contacting some of you to explore the possibility of easements or other reroute opportunities. Two years of COVID limitations and heavy weather have certainly impacted area TRAILS, ours and those in the PARK so we'll be asking for assistance maintaining and creating.

### 2021 Highlights In Review

2021 allowed us to resume our much enjoyed pot lucks. We saw and met new faces and reconnected with many of our longtime friends and neighbors.

BINGO & Movie Nights were introduced and well received. We completed a couple of trail maintenance and general maintenance projects started by past boards. We were also able to perform weekly trail maintenance on our SCTA trails as weather & participation allowed.

SCTA Hosted another well received Equine Rescue & Resources Seminar. Presenters included members from the Fentress County Rescue Squad, members from Fire House 11, 2 National Park Service Search & Rescue Squad members, a Detective from the Fentress County Sheriff's Dept. and representatives from AirMedcare & MASA. Approximately 80 attendees were noted.

A Hoof Care Clinic was also held. SCTA hosted 2 local farriers as well as a local bare foot trimmer. Attendees were able to learn the importance of proper and timely hoof care, how to identify areas of possible concern for early care followed with questions and answers.

## Spruce Creek Trails Association, Inc. Mission Statement July 26, 2003

It shall be the mission of the Spruce Creek Trails Association, Inc., to enhance and protect the property investment of Spruce Creek Ares Subdivision landowners through its trails program. This investment is affected significantly by the drawing power of the trails located within Spruce Creek Acres leading to trails in the Big South Fork National River & Recreation Area and to other locations in Fentress County. Not only does Spruce Creek have scenic beauty within its own trail system, but property owners have the ability to travel by horse onto Big South Fork and other areas and to visit the unique beauty of cliff overlooks into the gorge, archeological formations, cultural landscapes, rivers and streams, and other natural wonders.

Spruce Creek Trails Association, Inc., shall have the following guiding principles to accomplish its mission:

Trails shall be maintained in such a condition as to protect the beauty 1. of the land and the safety of the users.

A good-neighbor policy shall allow the sharing and reciprocity of 2. Spruce Creek trails with other organizations and members of the community as long as trails can be maintained without deterioration to the point of becoming unsustainable.

Spruce Creek Trails Association, Inc., shall actively pursue 3. harmonious relationships with Big South Fork National River & Recreation Area, the County of Fentress, and equestrian community neighbors. The common interests related to equestrian activities are hereby recognized as important to Spruce Creek's interests and goals.

To relieve any anxiety any Spruce Creek landowner might have related to property outside of trails, it is hereby stated that this mission shall in no way impinge upon or attempt in any manner to regulate, control, or otherwise influence a landowner's property rights except trail property owned by Spruce Creek Trails Association, Inc.

This letter is to inform you of an important milestone concerning your investment in Spruce Creek Acres. We recognize, as we are sure you do, that trails within Spruce Creek are an integral and vital aspect of your land investment. They hold the drawing power to what has been dubbed the "Jewel of the Cumberland," Big South Fork National River & Recreation Area. They provide you the means of easy access to some of the most spectacular views of canyon bluffs, garges, streams, rock formations, and woodlands in the east.

As you may be aware, the developers of Spruce Creek held the concept that upon completion, or near completion, of Spruce Creek an organization would assume ownership of the trails.

We are excited about this new development. This organization is very necessary, not only in terms of managing Spruce Creek trails, but also in interfacing with the National Park Service. Corporate headquarters will be located at Ricky Rains' property at 463 Spruce Creek Drive.
